THE BOARD WANTS TO HEAR ABOUT YOUR COVID-19 EXPERIENCES

Members across the state have been instrumental in their agency's year-plus response to the COVID-19 pandemic. Environmental Health (EH) staff have applied well-honed training and experience to case/contact work, proving complex and rapidly changing COVID guidance to the community, supporting mass testing and vaccination efforts, while continuing to perform routine inspection/field work under limiting and changing safety procedures. Some EH programs have been impacted by a reduced workforce due to staff being reassigned to response work or staff facing child-care or other family challenges. The past 18 months have shown how effectively EH and other public health staff can shine in protecting and promoting the health of our collective communities. That success has come at the cost of exhausted staff and programs facing vacancies from retirements and other staff turnover, along with programmatic backlogs.

The board would like to hear from you about those challenges and successes, either as individuals or programs. We know that telling stories is one of our most effective tools for promoting behavior change or securing resources for public health. We want your stories so that we can share amongst each other (anonymously as desired) the shared experiences, burdens, and successes that we have faced. We also wish to promote and support you as we continue to

respond to and recover from COVID-19 efforts. EH staff and programs need support as we slowly emerge from extensive response tasks to the new normal that will define our collective efforts for at least the next few years.
